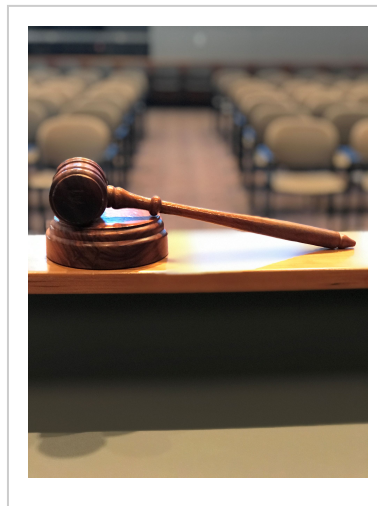

Consent Items

Council approved the following items:

- Approved the use of South Allen Street, between East Beaver and East Foster Avenues, the Bill Welch Plaza, and the Municipal Building lobby and restrooms, with conditions, for the Food Truck Rally in the Valley event, sponsored by Housing Transitions, on Sunday, September 9, 2018, from 12 p.m. to 3 p.m.
- Approved changing H Alley to one-way, from West Calder Way to West Beaver Avenue, to allow for student move-in to The Graduate, on Saturday, August 18, 2018, from 7 a.m. to 5 p.m.
- Approved the use of Orchard Park Bicycle Path, from Welch Pool to Blue Course Drive, with conditions, for the annual Centre Region Parks and Recreation Youth Triathlon on Saturday, July 21, 2018, from 8 a.m. to 11 a.m.
- Approved the closing of the Homan Avenue cul-de-sac, on Saturday, July 7, 2018, from 5 p.m. to midnight for the annual Homan Avenue Block Party.
- Approved the closing of South Allen Street (between College and West Nittany Avenues), and the use of the Municipal Building lobby and

restrooms, on Sunday, July 29, 2018, from 9 a.m. to 6 p.m., for the Centre County Youth Service Bureau's Annual Last Cruise Car Show.

- Approve the closing of Miller Alley, between New Alley and West Beaver Avenue, with conditions, as well as a waiver for rooftop occupancy, for the Over the Edge rappelling event, on Wednesday and Thursday, October 10 & 11, 2018, from 7 a.m. to 7 p.m., for the FaithCentre and Interfaith Human Services fundraising event.
- Awarded the contract for the Westerly Parkway and State High Entrance Traffic Signal Project to Wyoming Electric & Signal Inc., the low bidder, in the amount of \$242,870.30.
- Awarded the contract for the Street & Alley Resurfacing Project to Glenn O. Hawbaker, the low bidder, in the amount of \$376,700.
- Accepted the resignation of Vansh Prabhu, with regret, from the CDBG Citizens' Advisory Committee, effective immediately.

General Administration

A. Adoption of the 2019-2023 Capital Improvement Plan (CIP)

Council received the CIP on May 14 and a public hearing was held on June 18. Council received both oral and written comment on the proposed CIP at the Public Hearing. Council was asked to conclude its review, including consideration of public comments, and move to adopt the CIP at this meeting, including any modifications or amendments to the original proposal. Council reviewed the proposed projects contained in the CIP on June 4 and June 11.

Following the review sessions and public hearing, Council held a final wrap-up and review session on June 18. Council has also reviewed all comments that were received, both written and oral, as part of its review of the CIP.

No additional comments were received in the Manager's Office. Council approved the 2019-2023 CIP.

Planning and Zoning

A. Request for Vacation of Holly Alley

Council held a public hearing on the vacation of a portion of Holly Alley, between Fraternity Row and Clover Alley, earlier in the meeting. Council went on to approve the Ordinance.
